A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN CITY OF SAN DIEGO, DON BERMAN AND
PENNY BERMAN, CO-TRUSTEES OF THE 2000 BERMAN
FAMILY TRUST

WHEREAS, on October 3, 2019, Plaintiffs Don and Penny Berman, co-trustees of the 2000 Berman Family Trust, filed suit in San Diego Superior Court against the City of San Diego for damages sustained because of flooding onto their property at 4617 Antioch Place, San Diego, California 92115, on December 6, 2018. The suit is entitled *Don Berman et al. v. City of San Diego*, Superior Court Case No. 37-2019-00052457-CU-OR-CTL (Litigation); and

WHEREAS, in closed session on April 27, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; Absent, None; authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement and General Release Agreement; NOW THEREFORE

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$172,595.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from the litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$172,595.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.


