A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN RICHARD KEITH ROBERSON AND THE CITY
OF SAN DIEGO.

WHEREAS, on October 18, 2019, Richard Keith Roberson filed suit against the City of San Diego alleging personal injury arising from a bicycle accident that occurred at 4651 Monroe Avenue, in the City of San Diego, on November 6, 2018. The suit is entitled *Richard Keith Roberson v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00055210-CU-PO-CTL; and

WHEREAS, in Closed Session on May 18, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 7, 8, and 9; Nays, None; and Absent, District 6, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1) Authorizes the Mayor or his designee to pay the sum of \$72,500.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury Complaint filed by Richard Keith Roberson, entitled *Richard Keith Roberson v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00055210-CU-PO-CTL.

2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$72,500.00 from Water Fund No. 700011, for the purpose of settling this claim.


