A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AND APPROVING THE PROJECT LIST TO BE FUNDED BY FISCAL YEAR 2022 ROAD MAINTENANCE AND REHABILITATION ACCOUNT (RMRA) FUNDS AND AUTHORIZING THE AWARD, EXECUTION AND FUNDING OF FIVE PROJECTS: SLURRY SEAL GROUP 2123, SLURRY SEAL GROUP 2124, SLURRY SEAL GROUP 2221, SLURRY SEAL GROUP 2222, AND SLURRY SEAL GROUP 2223.

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated \$27,764,640 in RMRA funding in Fiscal Year 2022 from SB 1; and

WHEREAS, this is the fifth year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and WHEREAS, the City has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the City used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the community's priorities for transportation investment; and

WHEREAS, RMRA has become a critical component of the City's Resurfacing Program over the past few years and will help to ensure that the City continues to maintain pavement conditions which the City of San Diego is projected to receive \$27,764,640 in Fiscal Year 2022 from this program and a requirement of the program is the approval of a project list by the governing body via Resolution, which is due to the California Transportation Commission by July 1, 2021; and

WHEREAS, the projected \$27,764,640 in funding is proposed to be allocated for slurry seal maintenance throughout the City and the project list includes streets planned for maintenance and repair in all nine Council Districts and is attached to this action as "City of San Diego – Fiscal Year 2022 Road Maintenance and Rehabilitation Account Project List (Exhibit A)." This funding will provide proactive maintenance for 10-20% of each district's street network; and

WHEREAS, Slurry seal is an asphalt street surface treatment which consists of sand, emulsion, and water applied to a thin layer up to 3/8 of an inch thick used on streets which are generally in good condition to protect them from deterioration which minor surface repairs are completed by pavement specialists prior to the application of the slurry seal; and

WHEREAS, additionally, any failed areas of the pavement are removed and repaired prior to slurry seal application and this treatment extends the life of existing asphalt – resulting in lower lifecycle costs and reducing the amount of raw materials used for future overlay and reconstruction of these streets; and

WHEREAS, in Fiscal Year 2022, the Resurfacing Program plans to slurry seal more than 300 miles of streets, and this action will authorize the use of Fiscal Year 2022 RMRA funding to fund approximately 210 miles of repair via five projects: Slurry Seal Group 2123, Slurry Seal Group 2124, Slurry Seal Group 2221, Slurry Seal Group 2222, and Slurry Seal Group 2223; and

WHEREAS, the preliminary list of streets to be slurry sealed with RMRA funding is attached; however, to avoid any construction conflicts, the final list of streets may be modified. Using a Pavement Management System, streets are selected for slurry sealing based on the established criteria including:

- Overall Condition Index (OCI)
- Maintenance History
- Street Functional Classification
- Traffic Loading
- Proximity to Emergency Facility/School/Tourist Attraction
- Coordination with Public and Private Construction

WHEREAS, the Resurfacing Program works closely with the City's Multimodal Program to implement bicycle striping and safety improvements as part of slurry seal and asphalt overlay projects and from Fiscal Year 2016 through the first half of Fiscal Year 2021, more than 280 miles of new or improved bicycle facilities have been implemented and the Resurfacing Program constructs approximately three quarters of these bicycle network improvements, mostly via slurry seal projects. High-visibility crosswalk striping is also installed after application of slurry seal to improve pedestrian crossings; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets

infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the "City of San Diego - Fiscal Year 2022 Road Maintenance and Rehabilitation Account Project List," attached as Exhibit A and on file in the Office of the City Clerk as Document No. RR-<u>313618</u>, will be funded in part or solely by RMRA Revenue.

2. That the Mayor, or his designee, is authorized to advertise, award, and execute five construction contracts with the lowest responsible and reliable bidders, in an amount not to exceed \$5,500,000 for Slurry Seal Group 2123, \$5,500,000 for Slurry Seal Group 2124, \$5,500,000 for Slurry Seal Group 2221, \$5,500,000 for Slurry Seal Group 2222, and \$5,764,640 for Slurry Seal Group 2223, contingent upon the adoption of the Fiscal Year 2022 Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Chief Financial Officer is authorized to expend funds not to exceed \$5,500,000 from Fund 200731 – Road Maintenance & Rehabilitation Fund for Slurry Seal Group 2123, \$5,500,000 from Fund 200731 – Road Maintenance & Rehabilitation Fund for Slurry Seal Group 2124, \$5,500,000 from Fund 200731 – Road Maintenance & Rehabilitation Fund for Slurry Seal Group 2221, \$5,500,000 from Fund 200731 – Road Maintenance & Rehabilitation Fund for Slurry Seal Group 2222, and \$5,764,640 from Fund 200731- Road Maintenance & Rehabilitation Fund for Slurry Seal Group 2223, contingent upon the adoption of the Fiscal Year 2022 Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for the construction contract expenditures are, or

will be, on deposit with the City Treasurer.
