A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE SAN DIEGO CITY FIREFIGHTERS, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL145 REGARDING TERMS AND CONDITIONS OF EMPLOYMENT FOR FISCAL YEAR 2022.

WHEREAS, by San Diego Resolution R-313138, the San Diego City Council (Council) approved a Memorandum of Understanding between the City of San Diego (City) and the San Diego City Firefighters, International Association of Firefighters, Local 145 (Local 145) regarding terms and conditions of employment for employees represented by Local 145 for Fiscal Year 2021; and

WHEREAS, Article 31 of the Memorandum of Understanding provides a reopener to negotiate proposals for a successor Memorandum of Understanding (MOU); and

WHEREAS, the City's Management Team and representatives of Local 145 met and conferred pursuant to the reopener provision and reached a tentative agreement on terms and conditions of employment for a one-year MOU, and Local 145 members ratified the tentative agreement; and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the state law related to collective bargaining between the City and its represented employees, and Council Policy 300-06, it is within the discretion of the Council to approve the MOU; and

WHEREAS, the Council desires to approve the MOU between the City and Local 145; NOW, THEREFORE,

BE IT RESOLVED, pursuant to the authority of the MMBA and Council Policy 300-06, the Council of the City of San Diego approves the MOU between the City and Local 145 for Fiscal Year 2022, on file in the Office of the City Clerk as Document No. 22-313632 APPROVED: MARA W.
