A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AN APPLICATION TO THE
CALIFORNIA TRANSPORTATION COMMISSION TO
SECURE TRADE CORRIDOR ENHANCEMENT PROGRAM
GRANT FUNDING FOR THE LA MEDIA ROAD
IMPROVEMENTS PROJECT AND ALL RELATED ACTIONS.

WHEREAS, the California Road Repair and Accountability Act of 2017 established the Trade Corridor Enhancement Program (TCEP), which provides grant funding for infrastructure improvements along designated corridors with high volumes of freight movement; and

WHEREAS, the Otay Mesa Port of Entry crossing is the largest commercial crossing on the California-Mexico border; and

WHEREAS, the La Media Road Improvements Project (Project) scope includes widening La Media Road between SR-905 and Siempre Viva Road. Additionally, this project will also improve drainage at the intersection of La Media Road and Airway Road; and

WHEREAS, this project will increase economic competitiveness by promoting sustained export activity and will address environmental sustainability by reducing truck idling and eliminating congestion caused by trucks on local streets; and

WHEREAS, City staff have determined that this Project is eligible for \$22.7 million in TCEP grant funding; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to take all necessary actions to make applications to the California Transportation Commission and to secure grant funding for

an amount not to exceed \$22.7 million in TCEP grant funding for CIP S-15018, La Media Rd Improvements, for the purpose of construction.

2. That the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$22.7 million if the grant funding is secured.

3. That the Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.

4. That the Chief Financial Officer is authorized to increase the Capital Improvement Program Budget in CIP S-15018, La Media Rd Improvements, Fund 600001, Grant Fund - State, for an amount not to exceed \$22.7 million of TCEP grant funding, contingent upon receipt of a fully executed grant agreement.
