A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN CHARLES MAAS AND THE CITY OF SAN
DIEGO.

WHEREAS, on October 31, 2019, Charles Maas filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred at the corner of Grape Street and Fern Street, in the City of San Diego, on May 5, 2019. The suit is entitled *Charles Maas v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2019-00057842-CU-PO-CTL; and

WHEREAS, in Closed Session on June 15, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 7, 8, and 9; Nays, None; and Absent, District 6, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1) Authorizes the Mayor or his designee to pay the sum of \$80,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury Complaint filed by Charles Maas, entitled *Charles Maas v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2019-00057842-CU-PO-CTL.

2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$80,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.
