A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DESIGNATING THE 2300 BLOCK OF MONUMENT ROAD (INTERSECTION OF HOLLISTER STREET AND MONUMENT ROAD), LOCATED IN THE TIJUANA RIVER VALLEY COMMUNITY, TO BE KNOWN AS ELIZABETH 'BETTY' CUEN STREET.


