A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
CYNTHIA MITCHELL AND THE CITY OF SAN DIEGO

WHEREAS, on October 16, 2018, Cynthia Mitchell filed a lawsuit against the City of San Diego [City] alleging economic and emotional distress damages arising from her employment with the City, entitled *Cynthia Mitchell v. City of San Diego, et al.* San Diego Superior Court Case No. 37-2018-00054689-CU-OE-CTL.

WHEREAS, in Closed Session on July 13, 2021, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9;; Nays, none; and absent, none, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from Cynthia Mitchell's employment with the City of San Diego.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$250,000 from Public Liability Fund No. 720045, for the purpose of settling this claim.
