A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING COUNCIL POLICY NO. 100-03.

WHEREAS, The City of San Diego (City) adopted a Transient Occupancy Tax (TOT) Policy, Council Policy 100-03, in March of 1965 (last amended in September of 2005) to set forth the purpose of TOT, establish the protocol for potential increases to the future TOT rate, identify funding priority areas for utilization of TOT funds, and outline general guidelines by which the City will accept and evaluate applications for, and provide financial assistance from, TOT funds; and

WHEREAS, City staff routinely collects data on each aspect of the TOT funding allocation programs from TOT funding applicants, recipients, and other stakeholders in the form of feedback from funding recipient performance reports, office hours, public meetings, applicant workshops, meetings of the Commission for Arts and Culture, equity assessments, and application evaluation panels; and

WHEREAS, upon analysis of this data by City staff, the existing Council Policy 100-03 requires revisions; and

WHEREAS, given these findings, City staff supporting the Commission for Arts and Culture and the Economic Development Department worked with the Department of Finance to recommend revisions to Council Policy 100-03 to strengthen programmatic integrity and reinforce alignment of the City's use of TOT funds; and

WHEREAS, the amendments to Council Policy 100-03 reflected in the materials supporting this Council item are proposed for approval; and

WHEREAS, the Council of the City of San Diego has reviewed the proposed amendments to Council Policy 100-03; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council Policy 100-03, entitled "Transient Occupancy Tax" is amended and replaced with the document on file in the Office of the City Clerk as Document No. RR- 313710.

BE IT FURTHER RESOLVED, the City Clerk is instructed to update the Council Policy Manual to include Council Policy 100-03 as amended by this resolution.
