A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
DEMETRIS WIMBERLEY AND THE CITY OF SAN DIEGO

WHEREAS, on November 19, 2018, Demetris Wimberley filed a lawsuit against the City of San Diego (City), and four individual supervisory employees, alleging economic and emotional distress damages arising from his employment with the City, entitled *Demetris Wimberley v. City of San Diego, et al.*, San Diego Superior Court Case No.

37-2018-00058664-CU-WT-CTL.

WHEREAS, in Closed Session on August 3, 2021, the San Diego City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; and absent, none, approved the settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$97,500 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents and employees, arising from Demetris Wimberley's employment with the City of San Diego.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$97,500 from Public Liability Fund No. 720045, for the purpose of settling this claim.




