DATE OF FINAL PASSAGE OCT 05 2021

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AN AMENDMENT TO THE GENERAL PLAN AND AN AMENDMENT TO THE UPTOWN COMMUNITY PLAN TO VACATE THE PUBLIC RIGHT OF WAY AND REMOVE A PORTION OF FRONT STREET, BETWEEN MONTECITO WAY AND DICKINSON STREET FROM THE UPTOWN COMMUNITY PLAN.

WHEREAS, Regents of the University of California, requested an amendment to the General Plan and the Uptown Community Plan to vacate the public right-of-way and remove a portion of Front Street, between Montecito Way and Dickinson Street, from the Community Plan Street Classification Network; and

WHEREAS, the project site is legally described as Front Street, 60 feet wide, bounded by Montecito Way to the south and Dickinson Street to the south, City of San Diego, County of San Diego, State of California; and

WHEREAS, the Planning Commission of the City of San Diego found the proposed amendment consistent with the General Plan; and

WHEREAS, under Charter section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, on October 5, 2021, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the General Plan and the Uptown Community Plan; and

WHEREAS, the Council of the City of San Diego has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it adopts the amendments to the Uptown Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-313740.

BE IT FURTHER RESOLVED, that the Council adopts an amendment to the General Plan.


