A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO DESIGNATING COUNCILMEMBER  
ELO-RIVERA AS THE CITY COUNCIL LIAISON TO THE  
CITY OF SAN DIEGO YOUTH COMMISSION.

WHEREAS, each year the City appoints elected officials to serve as representatives, alternates and liaison to various outside boards, commissions, committees, and governmental agencies; and

WHEREAS, the City has established the City of San Diego Youth Commission (Youth Commission) to serve as an advisory body to the Mayor, City Council, and City Manager on issues of interest to youth and pertaining to youth in the City; and

WHEREAS, pursuant to San Diego Municipal Code section 26.1604, the City Council shall designate one of its members to serve as the City Council Liaison to the Youth Commission; and

WHEREAS, the City Council Liaison, or a designee from his or her staff, shall attend the meetings of the Youth Commission, and shall facilitate the conduct of the Commission's meetings; and

WHEREAS, the City Council Liaison shall coordinate with staff to schedule the dates, times, and locations of each Youth Commission meeting; and

WHEREAS, this item designates Councilmember Elo-Rivera as the City Council Liaison to the Youth Commission; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council hereby designates Councilmember Elo-Rivera to serve as the City Council Liaison to the City of San Diego Youth Commission until a successor is duly appointed and confirmed .
