A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPOINTING JEFF KAWAR TO SERVE AS  
INTERIM INDEPENDENT BUDGET ANALYST.

WHEREAS, San Diego Charter (Charter) section 39.3 provides that the Independent Budget Analyst shall be appointed by the City Council; and

WHEREAS, on December 12, 2005, the City Council appointed Andrea Tevlin to serve as the Independent Budget Analyst; and

WHEREAS, Ms. Tevlin announced her retirement as Independent Budget Analyst; and

WHEREAS, the City will conduct a recruitment to fill the position of the Independent Budget Analyst; and

WHEREAS, the Council President recommends that the City Council appoint Jeff Kawar as Interim Independent Budget Analyst and fulfill the duties of the Independent Budget Analyst under San Diego Municipal Code section 22.2304 pending completion of the City's recruitment for an Independent Budget Analyst; and

WHEREAS, the Council finds that Mr. Kawar has the professional qualifications and experience to assume this appointment under the conditions set forth under San Diego Municipal Code section 22.2303; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW,  
THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council appoints Jeff Kavar to serve as the Independent Budget Analyst on an interim basis, and establishes his compensation in the position to be \$220,000 a year, and authorizes him to receive all benefits afforded to the position of Independent Budget Analyst, as set forth in Exhibit C of the approved Fiscal Year 2022 Salary Ordinance, with the appointment to take effect on November 13, 2021.
