A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
MARK AND WENDY HARTLINE AND THE CITY OF SAN
DIEGO.

WHEREAS, on September 3, 2019, MARK HARTLINE and WENDY HARTLINE filed a complaint against the City of San Diego (City), alleging property damage that occurred on September 1, 2017, at the residence of Plaintiffs located at 9197 Truman Street, entitled *Mark Hartline and Wendy Hartline v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00046353-CU-EI-CTL; and

WHEREAS, on November 2, 2021, the San Diego City Council by the following votes: Yeas, Districts: 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none; and Absent, none, approved the settlement for an amount consistent with the amounts set forth below;

NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$595,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the lawsuit entitled *Mark and Wendy Hartline v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00046353-CU-EI-CTL.

2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$595,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.




