DATE OF FINAL PASSAGE DEC 17 2021

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DESIGNATING THE UNIMPROVED PORTION OF ALCOTT STREET BETWEEN THE INTERSECTIONS OF WILLOW STREET AND LOCUST STREET LOCATED IN THE POINT LOMA COMMUNITY TO BE KNOWN AS GREG BLOCK CANYON.

WHEREAS, pursuant to section 125.1130 of the San Diego Municipal Code, the Council of the City of San Diego may designate sections of streets with honorary names to recognize and honor individuals and organizations, who are of particular importance to the City of San Diego (City), or who have made significant contributions to improve the quality of life in the City; and

WHEREAS, pursuant to City Council Policy number 200-10, individuals and organizations eligible for recognition shall be sponsored by a councilmember, who shall demonstrate that the proposed honoree has sufficient community support through an affirmative vote of the relevant Community Council, Community Planning Group, or Recreation Council, or through written support from community leaders; and

WHEREAS, Greg Block is being sponsored by Councilmember Jennifer Campbell, of District 2, for his significant contributions to improve the quality of life in the City and for his particular importance to the City of San Diego, as evidenced by the written support submitted from numerous community leaders and members; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the unimproved portion of Alcott Street, between the intersections of Willow Street and Locust Street, located in the Point Loma Community, is hereby designated as Greg Block Canyon.


