A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ADOPTING THE E STREET GREENWAY  
MASTER PLAN AND THE 14TH STREET MASTER PLAN AS  
PART OF THE ADOPTION OF THE 2021 SAN DIEGO LAND  
DEVELOPMENT CODE/MUNICIPAL CODE UPDATE.

WHEREAS, the 2021 update to the Land Development Code (2021 Code Update Ordinance) to the San Diego Municipal Code codifies greenway street improvements to implement the 2016 Downtown Mobility Plan, including the formal adoption and ratification of the E Street Greenway Master Plan (2021) and the 14th Street Promenade Master Plan (2016); and

WHEREAS, one of the code amendments in the 2021 Code Update Ordinance relates to greenways in the Downtown Community Plan area, including the formal adoption and ratification of the 14th Street Promenade Master Plan and the E Street Greenway Master Plan, and is intended to implement the guidelines and principles of the Downtown Community Plan and Downtown San Diego Mobility Plan to address mobility goals and enhance the physical character and livability of Downtown through a clear network of greenway street linkages between Downtown's neighborhoods and open spaces, and create unique, attractive walkable corridors; and

WHEREAS, in 2016, the San Diego City Council (Council) adopted the Downtown San Diego Mobility Plan and associated amendments to the Downtown Community Plan identifying greenways to provide for a series of enhanced pedestrian facilities that are evenly distributed throughout Downtown to provide mobility choices through complete networks and enhanced environments for walking in Downtown; and

WHEREAS, the required improvements would help achieve a safe, convenient, and enjoyable pedestrian experience, resulting in a more desirable environment, thus helping to implement the City's mobility and climate goals, and would help implement the City's Climate Action Plan; and

WHEREAS, the 14th Street Master Plan and E Street Greenway Master Plan helps to implement the guidelines and principles of the Downtown Community Plan and Downtown San Diego Mobility Plan to provide guidance to further enhance the physical character and livability of Downtown through a clear network of greenway street linkages between Downtown's neighborhoods and open spaces and create unique, attractive corridors for pedestrians; and

WHEREAS, the 14th Street Master Plan and E Street Greenway Master Plan provide guidance for the construction of improvements that enhance the quality of the pedestrian environment focusing of safety, convenience, and encouraging walking, thus helping to implement the City's mobility and climate goals, consistent with the Downtown Community Plan and Mobility Plan; and

WHEREAS, on October 28, 2021, the Planning Commission of the City of San Diego considered the 2021 Code Update Ordinance, and pursuant to Planning Commission Resolution No. 5164-PC, the Planning Commission voted to recommend approval of the 2021 Code Update, which included the adoption of the 14th Street Master Plan and E Street Greenway Master Plan; and

WHEREAS, on December 13, 2021, the Council held a public hearing for the purpose of considering the adoption of the 2021 Code Update Ordinance, which included the adoption of the 14th Street Master Plan and E Street Greenway Master Plan; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council adopts the E Street Greenway Master Plan (2021), on file in the Office of the City Clerk as Document No. RR- 313817-1.

BE IT FURTHER RESOLVED, by the City Council of the City of San Diego, that the Council adopts the 14th Street Promenade Master Plan (2016), on file in the Office of the City Clerk as Document No. RR- 313817-2.


