A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS OF
COUNCILMEMBERS TO STANDING COMMITTEES FOR
CALENDAR YEAR 2022.

WHEREAS, Rule 6.1 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides for specific standing committees of the Council of the City of San Diego (Council); and

WHEREAS, Rule 6.2.1 provides that no later than the second Council meeting in January of each year, the Council President shall nominate the committee chair, vice chair, and committee members for each committee, subject to confirmation by a majority vote of the Council; and

WHEREAS, Council President Sean Elo-Rivera submitted nominations for the committee chairs, vice chairs, and committee members for the standing committees of the Council for calendar year 2022, and now seeks Council confirmation of the appointments; and

WHEREAS, Council desires the standing committee appointments be effective on December 16, 2021 to accommodate a special meeting of the Committee on Active Transportation and Infrastructure planned for December 15, 2021; and

WHEREAS, the additional appointments of Councilmembers to serve on the City's Audit Committee, which is governed by the San Diego Charter, and appointment of a Council President Pro Tem will be considered by the Council in separate actions and are not included in this resolution; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council confirms the following appointments of the committee chair, vice chair, and committee members for each standing committee pursuant to Municipal Code section 22.0101 effective on December 16, 2021, to serve for a term of one year, and until a successor is duly appointed and confirmed:
