DATE OF FINAL PASSAGE JUL 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO EXEMPTING TWO PROGRAM COORDINATOR
POSITIONS IN THE HOMELESSNESS STRATEGIES AND
SOLUTIONS DEPARTMENT FROM THE CLASSIFIED
SERVICE.

WHEREAS, on June 2, 2022, the Civil Service Commission of the City of San Diego (City) reviewed a request from the Homelessness Strategies and Solutions Department (Department) to exempt two Program Coordinator positions from the Classified Service; and

WHEREAS, the Data Systems and Management Program Coordinator position will be responsible for data systems design and management. This position will perform analysis to develop project development and housing policy to reduce and prevent homelessness; perform long-range fund planning; develop tools to gather data in order to make informed decisions for programming; and develop policies, priorities, and work procedures that align with the Community Action Plan on homelessness; and

WHEREAS, the Grants Management Program Coordinator position will be responsible for managing and administering federal and non-federal grants. This position will prepare, monitor, and implement grant activities and ensure operational and reporting requirements are fulfilled; identify and acquire local, state, and federal support and funding; develop policies related to grant strategies; liaison with funding agencies to represent the City; and develop policies, priorities, and work procedures that align with the Community Action Plan on homelessness; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service shall include “[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council”; and

WHEREAS, upon review of the duties and responsibilities of the Program Coordinator positions, as described by the Department, the Civil Service Commission found they meet the intent of Charter section 117 to exempt the positions from the Classified Service; and

WHEREAS, the finding by the Civil Service Commission is set forth in the memorandum dated June 3, 2022 to the Honorable Council President and members of the City Council (Council), prepared on behalf of the Civil Service Commission by the Personnel Director, on file in the Office of the City Clerk as Document No. OO-21489; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to Charter section 117, the Council exempts from the Classified Service the two Program Coordinator positions described by the Department.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
