DATE OF FINAL PASSAGE JUL 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO EXEMPTING ONE PROGRAM MANAGER
POSITION AND ONE PROGRAM COORDINATOR POSITION
IN THE PARKS AND RECREATION DEPARTMENT FROM
THE CLASSIFIED SERVICE.

WHEREAS, on June 2, 2022, the Civil Service Commission of the City of San Diego (City) reviewed a request from the Parks and Recreation Department (Department) to exempt one Program Manager position and one Program Coordinator position from the Classified Service; and

WHEREAS, the Program Manager position will be responsible for overseeing and managing recreation programming for all City recreation centers, facilities, and parks. This position will focus on deliverables associated with recommendations from the Recreation Equity Audit; develop and recommend policy related to opportunities for everyone to play, explore, and learn; manage the Come Play Outside initiative budget and purchasing functions; and ensure equity of recreation opportunities across diverse communities and geographic areas; and

WHEREAS, the Program Coordinator position will manage the Citywide Animal Welfare and the San Diego Humane Society contract. This position will integrate internal controls, policies, and procedures and mitigate potential liability issues related to animal welfare; enforce leash laws; maintain contract compliance; develop policies such as how the City engages with stakeholders on the use of public space for leashed dog parks; and implement education campaigns; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service shall include “[m]anagerial employees having significant responsibilities for formulating or

administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, upon review of the duties and responsibilities of the positions, as described by the Department, the Civil Service Commission found they meet the intent of Charter section 117 to exempt the positions from the Classified Service; and

WHEREAS, the finding by the Civil Service Commission is set forth in the memorandum dated June 3, 2022 to the Honorable Council President and members of the City Council (Council), prepared on behalf of the Civil Service Commission by the Personnel Director, on file in the Office of the City Clerk as Document No. OO-21495; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to Charter section 117, the Council exempts from the Classified Service the one Program Manager position and one Program Coordinator position described by the Department.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
