DATE OF FINAL PASSAGE JUL 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING TWO PROGRAM MANAGER  
POSITIONS IN THE PLANNING DEPARTMENT FROM THE  
CLASSIFIED SERVICE.

WHEREAS, on June 2, 2022, the Civil Service Commission of the City of San Diego (City) reviewed a request from the Planning Department (Department) to exempt two Program Manager positions from the Classified Service; and

WHEREAS, the Public Spaces Program Manager position will oversee the Public Spaces Planning and Park Planning sections. This position will implement the Parks for All of Us initiative, which aims to address park system inequities; implement measures associated with the Parks Master Plan; manage and administer Citywide Park Development Impact Fees; develop and administer key implementation actions including the Chollas Creek Watershed Regional Park Master Plan, Citywide Trails Master Plan, Citywide Recreational Value Inventory, and a Parks Needs Index; and develop policies and procedures for these plans in order to prioritize and allocate funding equity and key park planning policies; and

WHEREAS, the Chief Resiliency Officer Program Manager position will oversee the implementation of Climate Resilient SD, which is a comprehensive plan that addresses the changing climate. This position will serve as the City's Chief Resiliency Officer and manage and implement the Climate Resiliency SD plan; monitor and update the plan across City departments; develop policies for monitoring and updating the plan; develop policies to implement and maintain the Coastal Resilience Master Plan; participate in regional efforts related to adaptation planning and implementation; and oversee strategy and coordination for grant funding; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service shall include “[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council”; and

WHEREAS, upon review of the duties and responsibilities of the positions, as described by the Department, the Civil Service Commission found they meet the intent of Charter section 117 to exempt the positions from the Classified Service; and

WHEREAS, the finding by the Civil Service Commission is set forth in the memorandum dated June 3, 2022 to the Honorable Council President and members of the City Council (Council), prepared on behalf of the Civil Service Commission by the Personnel Director, on file in the Office of the City Clerk as Document No. OO-21498; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to Charter section 117, the Council exempts from the Classified Service the two Program Manager positions described by the Department.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from  
and after its final passage.


