A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO RECONFIRMING APPOINTMENTS TO THE
SAN DIEGO ASSOCIATION OF GOVERNMENTS BOARD OF
DIRECTORS AND CONFIRMING AN APPOINTMENT TO
THE NORTH COUNTY TRANSIT DISTRICT BOARD OF
DIRECTORS FOR CALENDAR YEAR 2022.

WHEREAS, each year the City appoints elected officials to serve as representatives, alternates, and liaisons to various outside boards, commissions, committees, and governmental agencies; and

WHEREAS, on December 10, 2021, by memorandum, Mayor Todd Gloria and Council President Sean Elo-Rivera recommended appointments of elected officials to serve as the City's representatives, alternates, and liaisons to various boards, commissions, committees, and governmental agencies, subject to Council confirmation; and

WHEREAS, the Council of the City of San Diego confirmed the appointments on December 14, 2021; and

WHEREAS, due to an error in the Form 806 posted in compliance with Fair Political Practice Commission Regulation section 18702.5, Council is now asked to reconfirm the appointments of the alternates to the Board of Directors of the San Diego Association of Governments (SANDAG) and the alternate to the SANDAG Transportation Committee; and

WHEREAS, due to scheduling considerations, the appointed representative to the Board of Directors of the North County Transit District is unable to serve and Council is asked to confirm a new representative for the 2022 calendar year; and

WHEREAS, the City has adopted and posted on its website the Fair Political Practices Commission Form 806 listing the proposed public official appointments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments of elected officials as representatives, alternates, and liaisons to outside boards, commissions, committees, and governmental agencies, to serve through December 2022, and until a successor is duly appointed and confirmed, are hereby confirmed:

 - Councilmember Jennifer Campbell, Rep.


