A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING THE 2022 LEGISLATIVE  
CALENDAR.

WHEREAS, each year, the Council of the City of San Diego (Council) adopts a schedule of meetings for the calendar year for the Council and its Standing Committees, commonly referred to as the legislative calendar; and

WHEREAS, the legislative calendar also includes the meetings of the Budget Review Committee, the Housing Authority, and the Public Facilities Financing Authority; and

WHEREAS, on October 12, 2021, the Council adopted the 2022 Legislative Calendar, on file in the Office of the City Clerk as Document No. RR-313743, and available on the City of San Diego's website; and

WHEREAS, San Diego Municipal Code section 22.0101 allows the Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting and sets forth the circumstances necessitating the change; and

WHEREAS, the Council President proposes to amend the 2022 Legislative Calendar, with changes to add new dates for certain Committee meetings, and adjourn and add in other meetings; and

WHEREAS, the amendments proposed to the 2022 Legislative Calendar will:

1. Add a Public Facilities Financing meeting on Tuesday, March 15, 2022, at 2:00 p.m.;

2. Add a Public Facilities Financing meeting on Tuesday, April 5, 2022, at 2:00 p.m.;
3. Add a Special Committee on COVID-19 Response and Recovery meeting on Monday, April 18, 2022, at 9:00 a.m.;
4. Add a Special Committee on COVID-19 Response and Recovery meeting on Monday, May 16, 2022, at 9:00 a.m.;
5. Remove the Land Use and Housing Committee meeting on Thursday, June 9, 2022, at 1:00 p.m.;
6. Add a Land Use and Housing Committee meeting on Thursday, June 16, 2022, at 1:00 p.m.;
7. Add a Special Committee on COVID-19 Response and Recovery meeting on Monday, June 20, 2022, at 9:00 a.m.;
8. Add a Special Committee on COVID-19 Response and Recovery meeting on Monday, July 18, 2022, at 9:00 a.m.;
9. Remove City Council meeting and Closed Session on Tuesday, October 4, 2022, at 10:00 a.m., 11:00 a.m., and 2:00 p.m.;
10. Remove the Budget and Government Efficiency Committee meeting on Wednesday, November 2, 2022, at 9:00 a.m.;
11. Add a Budget and Government Efficiency Committee meeting on Thursday, November 3, 2022, at 1:00 p.m.; and

WHEREAS, these amendments to the Legislative Calendar are being made to accommodate the extension of the Special Committee on COVID-19 Response and Recovery, the observance of Yom Kippur, the WIFIA Stormwater Loan transaction and a Sewer Revenue Bond transaction at the Public Facilities Financing Authority, and changes to Committee meeting dates as requested by the Committee Chairs; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the 2022 Legislative Calendar is hereby amended as reflected in the amended 2022 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 313920.
