DATE OF FINAL PASSAGE MAR 09 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$17,500 TO MANA DE SAN DIEGO FOR THE TIAS PROGRAM FOR LATINA SUCCESS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, MANA de San Diego (MANA) has requested funding for the Tias Program for Latina Success; and

WHEREAS, the requested funding will be used to support key staff positions connected to the Tias Program throughout the 2021-2022 program year to allow more outreach to be done to potential employers to get paid internships for Tias Program for Latina Success participants; and

WHEREAS, the MANA's request for funding for the Tias Program for Latina Success will benefit the public by supporting Latinas to complete their degrees and prepare for the workforce will not only increase their economic mobility and overall well-being but will also decrease their impact on government assistance programs programs and supply the local economy with the needed workfoce to support its continued growth; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2, 3, 4, 5, and 7 recommend a total allocation of \$17,500 to MANA for the purposes set forth in this resolution, attributed as follows: Council District 2 – \$5,000; Council District 3 – \$5,000; Council District 4 – \$5,000; Council District 5 – \$1,000; and Council District 7 – \$1,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: “Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and MANA (Agreement) in an amount not to exceed \$17,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-313930.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 2: Community Projects, Programs and

Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1102110002; \$5,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1103110003; \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1104110004; \$1,000 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005; and \$1,500 from Council District 7: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1107110007, for a total of \$17,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




