DATE OF FINAL PASSAGE MAR 09 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$14,300 TO THE JEWISH FAMILY SERVICES OF SAN DIEGO FOR THE ON THE GO – RIDES & SMILES PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, “CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES.”

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled “City Council Funding of Community Projects, Programs and Services” on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Jewish Family Services of San Diego (Jewish Family Services) has requested funding for the On the Go – Rides & Smiles program; and

WHEREAS, the requested funding will be used to cover staff time, program expenses, and administrative costs in the program; and

WHEREAS, Jewish Family Services’ request for funding for the On the Go – Rides & Smiles program will benefit the public by contributing to reduced societal, governmental, and institutional costs by addressing the specific needs of older adults and adults with disabilities, including reduced isolation and improved quality of life by allowing them to engage in the necessary activities of daily life, such as medical appointments, grocery shopping, and social outings; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2, 3, 5, 6, and 7 recommend a total allocation of \$14,300 to the Jewish Family Services for the purposes set forth in this resolution, attributed as follows: Council District 1 – \$3,000; Council District 2 – \$3,000; Council District 3 – \$1,500; Council District 5 – \$2,300; Council District 6 – \$2,000; and Council District 7 – \$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: “Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and the Jewish Family Services (Agreement) in an amount not to exceed \$14,300 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 313932 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1101110001; \$3,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1102110002; \$1,500 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1103110003; \$2,300 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1105110005; \$2,000 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1106110006; and \$2,500 from Council District 7: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1107110007 for a total of \$14,300, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

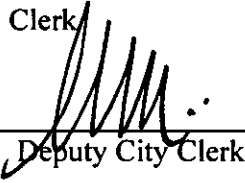

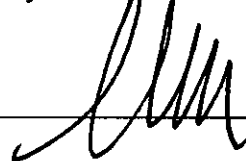
