A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
ANTHONY PHILIP GERALDI AND THE CITY OF SAN

WHEREAS, on May 11, 2020, ANTHONY PHILIP GERALDI filed a claim against the City of San Diego [City] alleging property damage arising from a break in the City's water main located at the intersection of Capps and Ray Streets in North Park; and

WHEREAS, in Closed Session on January 11, 2022, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none; and absent, none, approved the Settlement for an amount consistent with the amounts set forth below.

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$76,510.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the claim for property damage filed by Anthony Philip Gerdali.

2. Authorizes the Department of Finance to expend \$76,510.00 from Water Fund

No. 700011, for the purpose of settling this claim.


