A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE ACCEPTANCE AND  
EXPENDITURE OF GRANT FUNDS FROM THE HIGHWAY  
BRIDGE PROGRAM (HBP) FOR THE GEORGIA STREET  
BRIDGE IMPROVEMENTS PROJECT.

WHEREAS, originally constructed in 1914, the Georgia Street Bridge crosses over University Avenue in the Greater North Park Community and was placed on the National Register of Historic Places in 1998; and

WHEREAS, the City has worked with the California Department of Transportation (Caltrans) and the Federal Highway Administration to determine the most effective engineering alternative for the Georgia Street Bridge Improvements Project to address the geometric, structural and seismic deficiencies of the bridge in compliance with Caltrans and historic guidelines; and

WHEREAS, in 2003, City staff received approval to apply for and accept a Highway Bridge Replacement and Rehabilitation (HBRR) Program grant in the amount of \$28,000.00 for Preliminary Engineering San Diego Resolution R-219604 (Nov. 2, 1977); and

WHEREAS, in 2006, City staff received approval to apply for and accept a HBRR Program grant in the amount of \$576,000.00 for Preliminary Engineering Resolution R-301548; and

WHEREAS, in 2011, City staff received approval to apply for and accept a HBRR Program grant in the amount of \$938,240.00 for Preliminary Engineering Resolution 306907; and

WHEREAS, in 2013, City staff received approval to apply for and accept a HBRR Program grant in the amount of \$200,000.00 for Right-of-Way San Diego Ordinance O-20300 (Sept. 24, 2013); and

WHEREAS, in 2015, City staff received approval to apply for and accept a Highway Bridge Program (HBP) grant in the amount of \$9,500,000.00 for Construction Resolution R-309525; and

WHEREAS, in 2016, City staff received approval to apply for and accept a HBP grant in the amount of \$1,010,537.00 for Construction Engineering Resolution R-310622; and

WHEREAS, in 2017, City staff received approval to apply for and accept a HBP grant in the amount of \$300,000.00 for Construction Engineering Ordinance O-20849; and

WHEREAS, in 2018, City staff received approval to apply for and accept a HBP grant in the amount of \$510,000.00 for Construction Ordinance O-20946; and

WHEREAS, the project has been completed and is currently in the warranty phase, and the City of San Diego has requested an additional \$1,245,937.03 in federal grant funds to cover Construction and Construction Engineering costs for which local funds were previously used; and

WHEREAS, after the conclusion of the warranty phase and close-out of the Georgia Street Bridge Improvements Project, the unspent local fund budgets will be reallocated to other eligible projects pending City Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized, for and on behalf of the City, to take all necessary actions to secure additional Highway Bridge Program (HBP) grant funding in

an amount not to exceed \$1,245,937.03 for CIP S-00863, Georgia Street Bridge Improvements, to support construction.

2. That the Chief Financial Officer is authorized to accept, appropriate, and expend HBP grant funding in an amount not to exceed \$1,245,937.03, contingent upon receipt of a fully executed grant agreement.

3. That the Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.

4. That the Chief Financial Officer is authorized to increase the Capital Improvement Program Budget in CIP S-00863, Georgia Street Bridge Improvements, and to appropriate and expend an amount not to exceed \$1,245,937.03 within Fund 600000, Grant Fund – Federal.
