DATE OF FINAL PASSAGE APR 14 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,500 TO RANCHO DE LOS PEÑASQUITOS TOWN COUNCIL FOR THE FIESTA DE LOS PEÑASQUITOS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Rancho de los Peñasquitos Town Council has requested funding for the Fiesta de los Peñasquitos; and

WHEREAS, the requested funding will be used for marketing and equipment and supplies to set-up the event; and

WHEREAS, Rancho de los Peñasquitos Town Council's request for funding for the Fiesta de los Peñasquitos will benefit the public by supporting recovery from the global pandemic and economic crisis by sponsoring an event which helps local businesses and organizations find new clients, sell their wares and garner support for non-profit groups; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 5 and 6 recommend a total allocation of \$3,500 to the Rancho de los Peñasquitos Town Council for the purposes set forth in this resolution, attributed as follows: Council District 5 – \$1,000 and Council District 6 – \$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and Rancho de los Peñasquitos Town Council (Agreement) in an amount not to exceed \$3,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 314003 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005; and \$2,500 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1106110006, for a total of \$2,500, all to

provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
