A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO THE PILIPINO WORKERS CENTER OF SOUTHERN CALIFORNIA FOR ASIAN SOLIDARITY COLLECTIVE, DEPOSITING EMPOWERMENT THROUGH OUTREACH & URBAN REDEVELOPMENT, I AM GREEN, LLC, UPRISE THEATRE FOR RISE URBAN LEADERSHIP OF SAN DIEGO, AND THE URBAN CORPS OF SAN DIEGO COUNTY, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego received and evaluated five applications for Community Projects, Programs and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to the Pilipino Workers Center of Southern California for Asian Solidarity Collective to personnel payment, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Depositing Empowerment Through Outreach & Urban Redevelopment for team building and STEAM activity supplies, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to I Am Green, LLC for research and workshop expenses, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$1,500 to Uprise Theatre for Rise Urban Leadership of San Diego for training event expenses including marketing and rental space, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$10,000 to the Urban Corps of San Diego County for weed abatement services, as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for Depositing Empowerment Through Outreach & Urban Redevelopment, Uprise Theatre for Rise Urban Leadership of San Diego, and the Urban Corps of San Diego County, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that, for the Pilipino Workers Center of Southern California for Asian Solidarity Collective, I Am Green, LLC, and the Urban Corps of San Diego County, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and (1) the Pilipino Workers Center of Southern California for Asian Solidarity Collective in an amount not to exceed \$5,000, (2) Depositing Empowerment Through Outreach & Urban Redevelopment in an amount not to exceed \$5,000, (3) I Am Green, LLC in an amount not to exceed \$5,000, (4) Uprise Theatre for Rise Urban Leadership of San Diego in an amount not to exceed \$1,500, and (5) the Urban Corps of San Diego County in an amount not to exceed \$10,000, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314042-1 for the Pilipino Workers Center of Southern California for Asian Solidarity Collective, Document No. RR- 314042-2 for Depositing Empowerment Through Outreach & Urban Redevelopment, Document No.

RR- 314042-3 for I Am Green, LLC, Document No. RR- 314042-4

for Uprise Theatre for Rise Urban Leadership of San Diego, and Document No.

RR- 314042-5 for the Urban Corps of San Diego County.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$26,500 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1104110004, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
