A RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO APPROVING THE SETTLEMENT  
AGREEMENT BETWEEN DIANE GREENWOOD  
AND THE CITY OF SAN DIEGO.

WHEREAS, on May 26, 2020, Diane Greenwood filed suit against the City of San Diego alleging personal injuries arising from an incident that occurred on April 25, 2019, at or near 7464 Girard Avenue, La Jolla, California. The suit is entitled *Diane Greenwood v. City of San Diego*: San Diego Superior Court Case No. 37-2020-00015708-CU-PO-CTL [Litigation]; and

WHEREAS, in Closed Session on March 8, 2022, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None, and Absent, None; approved the Settlement of the Litigation against the City of San Diego for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1) Authorizes the Mayor or his designee to pay the sum of \$250,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation; and

2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$250,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.
