A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO COATS v. CITY OF SAN DIEGO.

WHEREAS, on September 30, 2020, Marguerite Coats filed a complaint against the City of San Diego (City) for personal injuries as a result of a trip and fall accident that occurred on January 13, 2020. Plaintiff brought suit in the Superior Court of California, County of San Diego. The suit is entitled *Marguerite Coats v. City of San Diego*, San Diego Superior Court Case No. 37-2020-00034612-CU-PO-CTL.; and

WHEREAS, in Closed Session on March 1, 2022, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 5, 6, 7, 8, and 9; Nays, None, and absent, None, approved the settlement; and; and

WHEREAS, the City Council in closed session on March 1, 2022, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$150,000 from Public Liability Fund No.720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents, employees and contractors arising from the personal injury complaint filed by Marguerite Coats.

2. Authorizes the Department of Finance to expend an amount not to exceed \$150,000 from Public Liability Fund No. 720045, for the purposes of settling this claim.
