A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO THE ECONOMIC DEVELOPMENT CORPORATION-SAN DIEGO COUNTY, THE KIWANIS FOUNDATION OF TIERRASANTA, AND THE SAN DIEGO RIVER PARK FOUNDATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated three applications for Community Projects, Programs and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Economic Development Corporation-San Diego County	Anchor Institution Collaborative	Create positive economic impacts.
Kiwanis Foundation of Tierrasanta	Tierrasanta Oktoberfest	Provide a fun event for the community.
The San Diego River Park Foundation	Cool River Education Program	Provide students with nature education.

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council District 7 recommends an allocation of \$2,000 to the Economic Development Corporation–San Diego County for event expenses, as set forth in this resolution; and

WHEREAS, Council District 7 recommends an allocation of \$7,000 to the Kiwanis Foundation of Tierrasanta for marketing and entertainment costs, as set forth in this resolution; and

WHEREAS, Council District 7 recommends an allocation of \$10,000 to The San Diego River Park Foundation for water quality testing supplies and other education program supplies, as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by City Council, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for the Economic Development Corporation–San Diego County and the Kiwanis Foundation of Tierrasanta, City Council waives Council Policy 100-06, section 3(g), which provides: “[a]n organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that, for the Economic Development Corporation of San Diego County and The San Diego River Park Foundation, the City Council waives Council Policy 100-06, section 8, which provides: “Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City and (1) the Economic

Development Corporation–San Diego County in an amount not to exceed \$2,000, (2) the  
Kiwanis Foundation of Tierrasanta in an amount not to exceed \$7,000, and (3) The San Diego  
River Park Foundation in an amount not to exceed \$10,000, under terms and conditions set forth  
in the Agreements on file in the Office of the City Clerk as Document No. RR- 314055-1

for the Economic Development Corporation–San Diego County, Document No.

RR- 314055-2 for the Kiwanis Foundation of Tierrasanta, and Document No.

RR- 314055-3 for The San Diego River Park Foundation.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$19,000 from Council District 7: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1107110007, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
