A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING DONATIONS OF TIME AND THE
COST OF CONSTRUCTION TO ASSETS IN BALBOA PARK
FOR FISCAL YEAR 2021.

WHEREAS, the City of San Diego's Parks and Recreation Department (Department) has received donations of time and construction costs towards work in Balboa Park. The donations have been approved by the City of San Diego's (City) Chief Operating Officer pursuant to City of San Diego Council Policy 100-02 – Donation Acceptance (Donations of Cash/Real Goods Valued at \$250,000 or Greater); and

WHEREAS, the California nonprofit corporation Friends of Balboa Park paid \$578,763 for the design and construction of an elevated tree-viewing platform and all new fencing for the historic Moreton Bay Fig Tree in Balboa Park; and

WHEREAS, the California nonprofit corporation Balboa Park Committee of 100 paid \$622,043 for the restoration of the original mural from the 1915 Panama Exposition on the facade of the Automotive Museum; and

WHEREAS, the City received volunteer support from the California nonprofit corporation Balboa Park Conservancy of the estimated cost of \$440,089 in volunteer hours for Park Visitor Center staffing, park ambassadors to provide information and wayfinding to visitors, tree stewards, garden stewards, administrative volunteers including Balboa Park Conservancy Board time for those who calculate their hours, event volunteers, and Department support volunteers who work with grounds maintenance workers; and

WHEREAS, acceptance of the donations will not require expenditures that exceed the Department's approved annual budget; and

WHEREAS, in accordance with Council Policy 100-02, the Department asks the City Council to accept these donations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it accepts the donation from the California nonprofit corporation Friends of Balboa of the design and construction of an elevated tree-viewing platform and all new fencing for the historic Moreton Bay Fig Tree in Balboa Park with a value of \$578,763, the donation from the California nonprofit corporation Balboa Park Committee of 100 of the restoration of the original mural from the 1915 Panama Exposition on the facade of the Automotive Museum with a value of \$622,043, and the donation from the California nonprofit corporation Balboa Park Conservancy of the estimated cost of \$440,089 in volunteer hours for Park Visitor Center staffing, park ambassadors to provide information and wayfinding to visitors, tree stewards, garden stewards, administrative volunteers including Balboa Park Conservancy Board time for those who calculate their hours, event volunteers, and Department support volunteers who work with grounds maintenance workers.


