A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO THE MT. CARMEL HIGH SCHOOL MUSIC FOUNDATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego received and evaluated one application for Community Projects, Programs and Services funding for the following purpose:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Mt. Carmel High School Music Foundation	44th Annual Tournament of Bands	Foster a sense of community, within the neighborhoods of District 5, by its show of support for the all the students from participating high schools throughout the district. Access to an afternoon of free top-rated entertainment as well as an opportunity for families to spend time together. Inspires young musicians in resident neighborhoods to continue their music endeavors.

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$5,000 to the Mt. Carmel High School Music Foundation for cost of the San Diego Police Department presence, rental of the required street signage and barriers, fees charged by the parade officials, insurance and the permit application fees, as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that, for the Mt. Carmel High School Music Foundation, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and the Mt. Carmel High School Music Foundation in an amount not to exceed \$5,000, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.

RR- 314074.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
