A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, THE CHIEF OPERATING OFFICER, THE CHIEF FINANCIAL OFFICER, THE FIRE CHIEF, THE OFFICE OF EMERGENCY SERVICES EXECUTIVE DIRECTOR, AND THE OFFICE OF EMERGENCY SERVICES PROGRAM MANAGER TO EXECUTE, FOR AND ON BEHALF OF THE CITY, APPLICATIONS AND DOCUMENTS FOR THE PURPOSE OF OBTAINING CERTAIN FEDERAL AND STATE FINANCIAL DISASTER ASSISTANCE.

WHEREAS, funding received from federal and state financial assistance programs directly supports the City's ability to respond to and recover from a catastrophic event; and

WHEREAS, the California Governor's Office of Emergency Services (Cal OES) manages the application for and distribution of federal and state public assistance funds available to local governments during and after a disaster or large-scale emergency event; and

WHEREAS, to be eligible to receive funding, Cal OES requires a new resolution every three years identifying which City officials are authorized agents and may execute and file disaster assistance documents; and

WHEREAS, this resolution updates and replaces San Diego Resolution No. R – 311513 (Jan. 31, 2018) which authorized designated City officials to execute and file, on behalf of the City, applications and documents for the purpose of obtaining certain federal financial assistance under Public Law 93-288, as amended by the Robert T. Stafford Disaster Relief and Emergency Act of 1988, and state financial assistance under the California Disaster Assistance Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor, the Chief Operating Officer, the Chief Financial Officer, the Fire Chief, the Office of Emergency Services

Executive Director, and the Office of Emergency Services Program Manager are authorized to execute, for and on behalf of the City, applications and documents for the purpose of obtaining certain federal and state financial disaster assistance.

BE IT FURTHER RESOLVED, that the Mayor, the Chief Operating Officer, the Chief Financial Officer, the Fire Chief, the Office of Emergency Services Executive Director, and the Office of Emergency Services Program Manager are authorized as agents, for and on behalf of the City, for all matters pertaining to assurances and agreements required by Cal OES.

BE IT FURTHER RESOLVED, that this resolution is effective for all open and future disasters for up to three (3) years following the approval date of this Resolution.

BE IT FURTHER RESOLVED that San Diego Resolution No. R- 311513, adopted January 31, 2018, is hereby rescinded.


