A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
CLIMATE ACTION PLAN REVIEW COMMITTEE.

WHEREAS, the City of San Diego (City) adopted a Climate Action Plan in 2015; and

WHEREAS, the 2015 Climate Action Plan set goals to reduce greenhouse gas emissions by half and source all energy from renewable sources by 2035; and

WHEREAS, the City is currently drafting an update to the Climate Action Plan and seeks community input on that update; and

WHEREAS, under San Diego Charter section 43(b), the Mayor recently created a citizens' committee named the Climate Action Plan Review Committee (Committee); and

WHEREAS, the Committee is temporary and established for the purpose of advising the City on the following areas: reviewing and providing feedback on the City's draft update to the Climate Action Plan, including the proposed strategies and actions; and developing recommendations on engaging residents, communities, and non-governmental organizations to guide implementation of the updated Climate Action Plan; and

WHEREAS, the Committee will dissolve upon the completion of the specified objectives, which is anticipated to occur by August 31, 2022; and

WHEREAS, the Committee will be composed of 21 members who shall serve, without compensation, subject to confirmation by the Council of the City of San Diego (Council); and

WHEREAS, the Council now seeks to confirm the Mayor's appointments to this Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Mayor to serve as members of the Climate Action Plan Review Committee, for the terms ending as indicated, are made and hereby confirmed:

BE IT FURTHER RESOLVED, that pursuant to Council Policy 000-13, for purposes of deliberation and consideration of appointment, it is determined that Bruce Mayberry is a resident of San Diego County, but not the City of San Diego, and has unique qualifications to serve as a member of the Committee, therefore, a conscious exception to Council Policy 000-13 is hereby declared.




