A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO ACCEPT, APPROPRIATE, AND EXPEND A \$453,569 GRANT FROM THE CALIFORNIA OFFICE OF EMERGENCY SERVICES, VICTIM SERVICES BRANCH, FAMILY JUSTICE CENTER PROGRAM AND TO AUTHORIZE THE SAN DIEGO CITY ATTORNEY TO EXECUTE THE GRANT AGREEMENT, INCLUDING AMENDMENTS, EXTENSIONS, AND RENEWALS.

WHEREAS, on February 23, 2022, the California Office of Emergency Services (Cal OES), Victim Services Branch, Family Justice Center Program, awarded grant funds in the amount of \$453,569 (Grant Award) to the City of San Diego (City) on behalf of Your Safe Place—A Family Justice Center (YSP) within the Office of the City Attorney (City Attorney); and

WHEREAS, the Grant Award is to expand YSP's client support and programming, professional development, and training, and support YSP's awareness campaign; and

WHEREAS, the Grant Award is available for encumbrance during the time period of April 1, 2022 through March 31, 2024 (Performance Period); and

WHEREAS, Cal OES requires Council of the City of San Diego (Council) approval to accept the Grant Award and authorization for the City Attorney to execute the grant agreement (Agreement) and any amendments, extensions, or renewals that may become necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Grant Award from Cal OES, Victim Services Branch, Family Justice Center Program is accepted in an amount not to exceed \$453,569 for the Performance Period.

2. That the City Attorney is authorized to execute the Agreement retroactively, and execute any amendments, extensions, or renewals of the Agreement that may become necessary for a period of up to five years from Fiscal Year 2022 through and including Fiscal Year 2027.

3. That the Chief Financial Officer (CFO) is authorized to appropriate and expend up to \$453,569 in grant funds from Cal OES, Victims Services Branch, Family Justice Center Program, including any amendments, extensions, or renewals of the Agreement for a period of up to five years from Fiscal Year 2022 through and including Fiscal Year 2027.

4. That any expenditures to date consistent with the Grant Award and the Agreement are ratified.

5. That the CFO is authorized to establish a special interest-bearing account for the Grant Award, if required.




