

RESOLUTION NUMBER R- 314108DATE OF FINAL PASSAGE JUN 01 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE LIBRARY DEPARTMENT TO SECURE, ACCEPT, APPROPRIATE, AND EXPEND GRANT FUNDING FROM THE CALIFORNIA STATE LIBRARY FOR PRELIMINARY DESIGN OF A NEW OAK PARK BRANCH LIBRARY.

WHEREAS, the current Oak Park branch library, located at 2802 54th Street in the City of San Diego (City), is a 5,200 square foot branch built in 1968; and

WHEREAS, a feasibility study was conducted in 2020 of a 1.5 acre site on existing City-owned land in the Chollas Community Park for a new Oak Park branch library, which, after such review, has been deemed sufficient for a new Oak Park branch library; and

WHEREAS, the current Eastern Area Community Plan calls for a new Oak Park branch library of at least 15,000 square feet, and phase one of the Library Master Plan, completed in 2021, recommends all new libraries to be at least 20,000 square feet to account for population growth; and

WHEREAS, the proposed Oak Park branch library will consist of a new 20,000 square foot single story building; and

WHEREAS, with the approval of the Council of the City of San Diego, the Library Department can use grant funding from the California State Library to complete preliminary design work on a new Oak Park branch library, paving the way for initiation of a Request for Proposal to build a new Oak Park branch library; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to take all necessary actions to secure grant funding from the California State Library for an amount not to exceed \$300,000 for preliminary design work on a new Oak Park branch library.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to accept, appropriate, and expend grant funding from the California State Library in an amount not to exceed \$300,000 for preliminary design work on a new Oak Park branch library.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to add CIP S-22011, preliminary design work on a new Oak Park branch library, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to increase the budget for CIP S-22011 by \$300,000, upon obtaining documentation that City has received the \$300,000 described above.

BE IT FURTHER RESOLVED, that if any grant funding discussed above is secured, that the Mayor or his designee, is authorized to establish a special interest-bearing account for such grant, if required.


