DATE OF FINAL PASSAGE JUN 23 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO ADVERTISE, AWARD, AND EXECUTE A CONTRACT FOR THE TECOLOTE CANYON TRUNK SEWER IMPROVEMENT, TECOLOTE CANYON GOLF COURSE WATER CONNECTION, AND SEWER GROUP 836 PROJECT TO THE LOWEST RESPONSIBLE AND RELIABLE BIDDER FOR AN AMOUNT NOT TO EXCEED \$51,000,000.

WHEREAS, the Tecolote Canyon Trunk Sewer Improvement, Tecolote Canyon Golf Course Water Connection, and Sewer Group 836 project (Project) will replace and rehabilitate 5.10 miles of sewer pipe, structural piers for above ground sewer, 600 linear feet, and site mitigation of water in Tecolote Canyon to provide additional capacity to the sewer system and to provide redundancy in the water system for the efficient delivery of water to the surrounding communities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to advertise and execute a construction contract with the lowest responsible and reliable bidder for an amount not to exceed \$51,000,000, of which \$48,000,000 is from CIP S-15020, Tecolote Canyon Trunk Sewer Improvement, Fund 700008, Muni Sewer CIP, and \$2,000,000 is from A-KB.00003, Main Replacements (B-15203, Tecolote Canyon GC Water Connection), Fund 700010, Water Utility CIP, and \$1,000,000 is from A-JA.00001, Sewer Main Replacements (B-13232, Sewer Group 836), Fund 700008, Muni Sewer CIP, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

2. That the Chief Financial Officer is authorized to expend funds under the established contract funding phases in a total amount not to exceed \$51,000,000, of which \$16,000,000 for the first phase is from CIP S-15020, Tecolote Canyon Trunk Sewer Improvement, Fund 700008, Muni Sewer CIP and \$2,000,000 for the first phase is from CIP A-KB.00003, Main Replacements (B-15203, Tecolote Canyon GC Water Connection), Fund 700010, Water Utility CIP, and \$1,000,000 for the first phase is from A-JA.00001, Sewer Main Replacements (B-13232, Sewer Group 836), Fund 700008, Muni Sewer CIP, and \$32,000,000 for all subsequent phases, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure under the established contract funding phases are, or will be, on deposit with the City Treasurer.


