DATE OF FINAL PASSAGE JUL 21 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO AWARD AND SIGN A CONSTRUCTION CONTRACT FOR REPLACEMENT OF THE HARBOR DRIVE TRUNK SEWER PROJECT IN AN AMOUNT NOT TO EXCEED \$36,000,000 AND RELATED ACTIONS.

WHEREAS, the Harbor Drive Trunk Sewer project (Project) includes replacement of sewer mains along Imperial Avenue (from Twelfth Avenue to Park Boulevard), Park Boulevard (from Imperial Avenue to East Harbor Drive), and East Harbor Drive (from Park Boulevard to Sewer Pump Station #5, located south of Sigsbee Street), as well as other upgrades and improvements to the existing wastewater collection system along the alignment; and

WHEREAS, the City of San Diego (City) began advertising the construction Project in April 2022 and bids from the responding contractors were opened on June 1, 2022; and

WHEREAS, based on the bids received, the cost of the entire phase-funded construction contract is not expected to exceed \$36,000,000, although at present only the first phase is fully funded; and

WHEREAS, the City is currently in the process of reviewing construction surety bonding and insurance documents, and Equal Opportunity Contracting Program compliance, to confirm the lowest responsive and reliable bidder; and

WHEREAS, pursuant to San Diego Municipal Code section 22.3102, the award of any Major Public Works contract over \$30,000,000 must be approved by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to award and sign a construction contract with the lowest responsible and reliable bidder to construct the Project for a total amount not to exceed \$36,000,000, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

2. That the Chief Financial Officer is authorized to expend funds under the established contract funding phases in a total amount not to exceed \$36,000,000, of which \$16,000,000 is for the first phase from CIP S-18006, Harbor Drive Trunk Sewer, Fund 700008, Muni Sewer CIP, and \$20,000,000 is for all subsequent phases and future construction contract change orders, contingent upon adoption of the Annual Appropriation Ordinance for the applicable year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure under the established contract funding phases are, or will be, on deposit with the City Treasurer.




