September 21, 2021 and from the Active Transportation and Infrastructure Meeting on

excused from the meeting of the COVID-19 Response and Recovery Committee on March 14,  
2022 due to advocacy on behalf of the City of San Diego with the National League of Cities  
Washington D.C. delegation.
