A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, APPROPRIATE, AND EXPEND \$50,000 IN GRANT FUNDING AND ANY ADDITIONAL FUNDING MADE AVAILABLE FROM THE CALIFORNIA DEPARTMENT OF ALCOHOL BEVERAGE CONTROL OFFICE OF TRAFFIC SAFETY TO REDUCE ALCOHOL-RELATED HARM FOR A PERIOD OF UP TO FIVE YEARS.

WHEREAS, the California Department of Alcohol Beverage Control Office of Traffic Safety (ABC OTS) Grant Program was developed to reduce alcohol-related harm in California; and

WHEREAS, ABC grant funding originates from the United States National Highway Traffic Administration and is passed through to OTS, which then awards grant funding to local jurisdictions, including San Diego; and

WHEREAS, the San Diego Police Department (Department) will use grant funding to conduct alcohol-related inspections, operations, enforcement, and education such as Minor Decoy operations, Shoulder Tap operations, IMPACT inspections, and Holiday enforcement focusing on such issues as alcohol sales to minors, underage drinking, and the sale of alcohol to over intoxicated patrons; and

WHEREAS, the Department's request for authorization to apply for ABC OTS grant funding was approved by the Grants Review Team on September 26, 2022; and

WHEREAS, City Council approval is required by the terms of the ABC OTS Grant Program; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized, for and on behalf of the City, to apply for and accept \$50,000 and any additional funding authorized by the ABC OTS, including any amendments, extensions, or renewals of the grant, for a period of up to five years, from Fiscal Year 2023 through Fiscal Year 2027, provided funding is secured and made available by the California Office of Traffic Safety, for the purpose of implementing the ABC OTS Grant Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Fiscal Year 2023 budget, accept, appropriate, and expend \$50,000 and any additional funding authorized by the ABC OTS, including any amendments, extensions, or renewals of the grant, for a period of up to five years from Fiscal Year 2023 through Fiscal Year 2027, provided funding is secured and made available by the California Office of Traffic Safety, for the purpose of implementing the ABC OTS Grant Program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to enter into all agreements and certifications necessary for the purpose of implementing the ABC OTS Grant Program.
