DATE OF FINAL PASSAGE MAR 10 2023

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A SECOND AMENDMENT TO THE ePLANSOFT CONTRACT WITH CARAHSOFT TECHNOLOGY CORP. AND INCREASING THE CONTRACT'S TOTAL NOT-TO-EXCEED AMOUNT TO \$3,932,825.00.

WHEREAS, in 2021, the Development Services Department (DSD) transitioned to cloud-based plan review and permitting for building and engineering projects. This transition utilizes the Accela permitting application for managing project reviews; and

WHEREAS, ePlansoft is a specialized tool that enables City Plan reviewers to assign workload, conduct simultaneous plan review, provide comments to customers, generate reports, and stamp approved plans; and

WHEREAS, the C1407 Carahsoft-ePlansoft contract needs to be increased to cover Annual license renewal and also cover the additional years to synchronize with the contract term with the ACCELA Permit System; and

WHEREAS, in FY 2024, DSD anticipates conducting a request for proposal for a new multi-year contract for its online permitting application and plan review tool; and

WHEREAS, the cost for the original Carahsoft ePlanSoft contract was a not-to-exceed amount (NTE) of \$2,096,810.00. The first amendment to the agreement increased the total cost to NTE on the contract to \$3,000,000.00 to include a LinkedIn subscription agreement. With this action, approving the second amendment to the agreement, the total contract will be increased to an NTE of \$3,932,825.00. Funding is available within Development Services Fund 700036; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the authorizing second amendment to Carahsoft ePlansoft contract to increase the contract agreement from an NTE of \$3,000,000 to an NTE of \$3,932,825.

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute a Second Amendment to the Carahsoft ePlansoft Contract with Carahsoft to increase the expenditure authority from an NTE of \$3,000,000 to an NTE of \$3,932,825 over the term of the contract pursuant to the terms and conditions set forth in the Second Amendment, on file with the City Clerk as Document No. RR- 314612.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an NTE of \$3,932,825 over the full term of the contract.

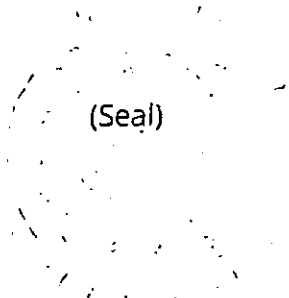
