A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DESIGNATING THE 700 BLOCK OF BEARDSLEY STREET AT THE INTERSECTION OF KEARNEY AVENUE LOCATED IN THE LOGAN HEIGHTS COMMUNITY TO BE KNOWN AS FATHER RICHARD H. BROWN STREET.
