Mayor because this matter is exclusively within the purview of the Council and does not affect
the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council President
Sean Elo-Rivera is hereby excused from attending all meetings of the Council and all meetings
of Standing Committees of the Council that may be held between September 6, 2023, through
September 30, 2023, due to family leave. If the schedule allows, Council President
Elo-Rivera reserves the right to attend any meetings during the excused time.
