A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
ISABEL IRAZOQUE AND THE CITY OF SAN DIEGO.

WHEREAS, on December 7, 2021, Isabel Irazoque filed a lawsuit against the City of San Diego alleging personal injuries arising from an accident that occurred on April 2, 2021, as a result of an alleged dangerous condition on Carmel Mountain Road. The suit is entitled *Isabel Irazoque v. City of San Diego*, San Diego Superior Court Case No. 37-2021-00051215-CU-PO-CTL (Litigation); and


WHEREAS, in Closed Session on January 8, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, 7, 8, and 9; Nays, none; with District 4 Vacant, approved settlement of the Litigation in the sum of \$77,500.00; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

1. Authorizes the Mayor or his designee to pay the sum of \$77,500.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, against City of San Diego, its agents and employees, arising from the Litigation;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$77,500.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.
