DATE OF FINAL PASSAGE MAR 22 2024

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE, APPROPRIATION, AND EXPENDITURE OF \$2.2 MILLION IN GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF JUSTICE AWARDED TO THE OFFICE OF THE CITY ATTORNEY TO IMPLEMENT THE SAN DIEGO REGIONAL GUN VIOLENCE RESPONSE TASK FORCE AND RELATED ACTIONS.

WHEREAS, in compliance with California's Budget Act of 2023 section 19.563 (June 27, 2023), the California Department of Justice (Cal DOJ) awarded the Office of the City Attorney (City Attorney) \$2.2 million in grant funds to implement the San Diego Regional Gun Violence Response Task Force (Grant Award); and

WHEREAS, the City Attorney will expend the Grant Award to reduce armed and prohibited persons, pursue gun violence restraining order petitions and services, eliminate ghost guns, and streamline communication among regional agencies; and

WHEREAS, the San Diego Regional Gun Violence Response Task Force will be comprised of local law enforcement and attorneys, organized within an already established regional law enforcement coordination area, and made up of six to ten members; and

WHEREAS, additional members may join the San Diego Regional Gun Violence Response Task Force through a memorandum of understanding with the City Attorney based on the need to carry out program priorities; and

WHEREAS, on January 31, 2024, the City Attorney entered into a Memorandum of Understanding with Cal DOJ that provides the terms and conditions under which Cal DOJ proposes to grant the Grant Award to the City Attorney for expenditure; and

WHEREAS, the Grant Award is available for encumbrance from October 1, 2023, to June 30, 2025, and expenditure until June 30, 2027 (Grant Period); NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is authorized to take all necessary actions to accept the Grant Award from Cal DOJ in an amount not to exceed \$2.2 million to implement the San Diego Regional Gun Violence Response Task Force for the Grant Period from October 1, 2023, to June 30, 2027.

BE IT FURTHER RESOLVED, that the Chief Financial Officer (CFO) is authorized to accept, appropriate, and expend an amount not to exceed \$2.2 million in Grant Award funds from Cal DOJ for the Grant Period from October 1, 2023, to June 30, 2027.

BE IT FURTHER RESOLVED, that any expenditures to date consistent with the Grant Award and Memorandum of Understanding between Cal DOJ and the City Attorney for the Grant Award are ratified.

BE IT FURTHER RESOLVED, that the CFO is authorized to establish a special interest-bearing account for the Grant Award, if required.
