A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
MARK SKEELS AND THE CITY OF SAN DIEGO

WHEREAS, on May 20, 2022, Mark Skeels filed a lawsuit against the City of San Diego (City), alleging damages resulting from his termination from the Office of the San Diego City Attorney, entitled *Mark Skeels v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2022-00019254-CU-OE-CTL (Litigation); and


WHEREAS, in Closed Session on February 12, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 6, 7, 8, and 9; Nays, District 5; and District 4 vacant, approved settlement for an amount consistent with the amount set forth below; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

1. Authorizes the Mayor or his designee to pay the sum of \$542,500.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, against City of San Diego, its agents and employees, arising from the Litigation;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$542,500.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.
