A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO RATIFY THE CONTRACT SPENDING FOR
FULL SERVICE MOBILE SHOWER RENTALS.

WHEREAS, the City of San Diego (City) issued an Invitation to Bid
(ITB 10089318-18-K) on January 5, 2018, for a Full-Service Portable Shower Rental provider
that could be used Citywide, by multiple departments, based on need; and

WHEREAS, the City subsequently awarded a contract to United Site Services of
California, Inc. for \$3 million over five years on March 16, 2018 (Contract), of which
\$2,457,047.41 was spent in the normal course; and

WHEREAS, unexpectedly high usage of the Contract was required in Fiscal Year 2019
and in response to the COVID-19 emergency, including Operation Shelter to Home launched on
April 1, 2020; and


WHEREAS, the City spent a total of \$4,201,871.30 beyond the \$2,457,047.41 during
these urgent circumstances and closed the contract on March 15, 2023; and

WHEREAS, the City seeks ratification of the additional \$4,201,871.30 spent; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the
information provided by City staff, with the understanding that this information is complete, true,
and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, the contract spend to the existing contract between the City of San Diego and United Site Services of California, Inc., on file with the Office of the City Clerk as Document No. RR- **315458** in the amount of \$4,201,871.30 is hereby ratified, bringing the total amount of the Contract to \$6,658,918.71.
