A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS AND
REAPPOINTMENTS TO THE COMMUNITY FOREST
ADVISORY BOARD.

WHEREAS, the Community Forest Advisory Board (Board) is established in San Diego Municipal Code (Municipal Code) section 26.0501 to advise the Mayor, Council of the City of San Diego (Council), and City Manager on policy issues relating to urban forestry; and

WHEREAS, Municipal Code section 26.0502 provides that the Board consists of fifteen members appointed by the Mayor and confirmed by the Council; and

WHEREAS, one member shall be appointed as Chair; nine members shall be appointed, one to represent each council district; one member shall be a landscape architect; one member shall be a certified arborist/urban forester; one member shall be a horticulturist/nursery industry representative; one member shall be a non-profit organization or governmental agency involved with forestry; and one member shall be an artist; and

WHEREAS, members shall be appointed to three-year terms and the terms of not more than five members shall expire in any year; and


WHEREAS, the expiration date of all terms shall be December 31; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,
