A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE FIRST AMENDMENT TO THE CONTRACT WITH TOM'S JANITORIAL SERVICES, INC. FOR JANITORIAL MAINTENANCE SERVICES.

WHEREAS, on January 12, 2021, the City of San Diego (City) issued an Invitation to Bid, No. 10089784-21-P, soliciting bids for janitorial maintenance services; and

WHEREAS, based on the results of the competitive process, the City awarded the contract to Tom's Janitorial Services, Inc. The contract expires August 16, 2026; and

WHEREAS, the City's Fleet Operations Division has nine vehicle facilities located at nine existing San Diego Police Department (SDPD) locations. The fleet operation facilities are not currently covered under the existing contract; and

WHEREAS, in March 2022, the Environmental Services Division (ESD) implemented the Food Scrap Recycling program pursuant to California Senate Bill 1382. ESD provided kitchen pails to SDPD to defer organic solids and food waste from landfills to organic waste recycling. Tom's Janitorial Services empties the pails and transfers the food waste to the appropriate waste dumpsters at each police facility; and

WHEREAS, additional services for the nine fleet operation facilities are \$297,000, and the additional services related to the ESD program is \$442,000, totaling \$739,000; and

WHEREAS, the City is seeking a First Amendment to the contract to increase the contract amount by \$739,000 for a total not to exceed amount of \$3,738,925; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the Contract with Tom's Janitorial Services, Inc. to increase the contract by \$739,000 for a total not to exceed amount of \$3,738,925 for janitorial maintenance services over the existing five-year term, pursuant to the terms and conditions set forth in the First Amendment, on file with the City Clerk as Document No. RR- **315640** and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an additional amount of \$739,000 to increase the total not to exceed amount to \$3,738,925 over the existing five-year term of the contract, \$442,000 from the General Fund (100000), Police Department (1914), and \$297,000 from the Fleet Operations Fund (Fund 720000), Fleet Operations Division (1317) for janitorial maintenance services contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
